## MILTON Keynes Rose Trust

## **1. BACKGROUND**

The Milton Keynes Rose (MK Rose) located in Campbell Park was co-commissioned by The Milton Keynes Rose Trust, formally the Milton Keynes Cenotaph Trust, with partners the Parks Trust and Milton Keynes Council.

It is a piece of public realm art designed by Internationally renowned artist Gordon Young and designer Andy Altman, offering the public opportunities for commemoration, celebration and contemplation. On the ground it takes the shape of a flower and where the "petals" intersect, engraved granite columns carry dedications in a calendar of significant dates designed to bring people to the space for social interaction and memory making. Opened in 2013, it has provided a gathering space that had hitherto not existed in Central Milton Keynes, through usage it has become an established place to be and one of the most photographed images of Milton Keynes. It is all embracing and inclusive, able to span different cultural groups and needs, groups from various faiths and beliefs or none. The Milton Keynes Rose Trust engage with the community to encourage use, promote the heritage stories contained within it and create a togetherness by sharing events that have and will go on shaping our lives, developing community cohesion.

The Trust support the co-curation with the public of new Pillars through a Pillar nomination process, this has seen nine new inscriptions over the past ten years including a Pillar dedicated to the Windrush Generation, the first permanent memorial outside London. Trustees individually work with a variety of community groups to hold events for instance Disability Awareness Day and Holocaust Memorial Day and as a Project Team with partners the Parks Trust in staging the Corporate and Para Pancake Race and to support the recently very successful MK Foodbank Guinness World Record beating MK CAN!

## 4. TERMS OF APPOINTMENT

Time commitment – Trustees are required to commit time to attend the following;

- 4 Trustee Meetings per year\*
- Key Events and Activities (4 per year)
- One specialist role on a project/subcommittee

\*Meetings are held at the Parks Trust Pavilion, Campbell Park. In person is preferable but virtual attendance is available as part of our D&I. This is a voluntary position and unpaid, however, there is no doubt that being a Trustee is one of the most rewarding & powerful ways you can contribute & support the local community. Joining the MK Rose Trust Board is a way to gain new skills and knowledge of the community in Milton Keynes & to increase your networks.

#### Duration

The initial appointment is for three years and expected to start during 2024. Successful candidates will be co-opted for an induction period of two meetings. Upon mutual agreement a decision shall be made to become a full Trustee.

Please note that certain individuals are not eligible to act as Trustees.

You will be ineligible if;

- 1. You have an unspent conviction for an offence involving dishonesty or deception
- 2. You are currently declared as bankrupt, subject to bankruptcy restrictions or an interim order
- 3. You have an individual arrangement to pay off debts with creditors
- 4. You are disqualified from becoming a company director
- **5.** You have previously been removed as a Trustee by either the Charity Commission or the High Court due to misconduct or mismanagement
- 6. You are under 18 years of age
